

## 6154 REACH for downstream users in the automotive industry

### Objective

The participants know the background and objectives of the REACH regulation and learn which sectors are affected. They will know when a restriction of use and an authorization requirement for substances apply. Participants can use IMDS to identify REACH-relevant basic substances and can also check their own material data sheets and those sent to them for REACH compliance. They know what actions they can take if they do not receive any information from their suppliers and how they can implement REACH in their operational practice to comply with the legal requirements.
