

# 6150 REACH for downstream Users in the automotive industry

#### **Objective**

The participants know the background and objectives of the REACH regulation and learn which business areas are affected. They will know when a restriction of use and authorisation obligation for substances applies. The participants can use the IMDS to identify REACH-relevant basic substances and can also check their own and incoming material data sheets for REACH compliance. The participants know about their duty to inform towards their customers and suppliers. They know what actions they can take if they do not receive any information from their suppliers and how they can implement REACH in their operational practice in order to comply with legal requirements. In addition, the participants know what changes have occurred as a result of Brexit.
