

## 6180 SVHCs and the SCIP database: recognizing and understanding reporting obligations

*To support the implementation of the EU Circular Economy Action Plan, the SCIP database was introduced by the ECHA to align with the obligations set out in the Waste Framework Directive 2008/98/EC. SCIP stands for Substances of Concern In articles as such or in complex objects (Products).*

*Since 5 January 2021, companies that place articles containing SVHCs (Substances of Very High Concern), which are on the REACH Candidate List, on the EU market have been obliged to submit information on these articles to the ECHA in the form of an SCIP dossier.*

*We will provide you with comprehensive information on the legal regulations and laws that govern your reporting obligations to the ECHA, including the sanctions that may be imposed in the event of non-compliance.*

### Objectives

To understand the EU Action Plan milestones, gain an overview of the requirements of the SCIP database, and understand who is affected by the reporting ECHA obligations. In addition, you will become familiar with data submission procedures, and understand how to prepare the SCIP notification so that you can plan your own data preparation schedule.

When processing SCIP dossiers, you will understand the required terms and the meaning of mandatory and optional fields. You will also know how to transfer the SCIP dossier (manually or automatically, S2S key). This serves as a basis for learning how to implement this in practice in the next step (see course 6181).

You will also be informed about potential sanctions for non-compliance with SCIP reporting obligations, along with guidance on how to avoid any possible fines.
