

6181 SCIP and IUCLID in practice: Implementing SVHC reporting obligations

To support the implementation of the EU Circular Economy Action Plan, the SCIP database was introduced by the ECHA to align with the obligations set out in the <u>Waste Framework Directive</u> 2008/98/EC. SCIP stands for **S**ubstances of **C**oncern **I**n articles as such or in complex objects (**P**roducts).

Since January 5 2021, companies that place articles containing SVHCs (Substances of Very High Concern), which are on the Reach Candidate List, on the EU market have been obliged to submit information on these articles to the ECHA in the form of an SCIP dossier.

Objectives

To become familiar with the SCIP notification procedure and the ECHA IT tool IUCLID, and to be able to work offline, online, or in your own IT systems using the IUCLID format. You will learn how to access ECHA services and tools. You will also become familiar with data submission options and be able to plan your own dossier preparation schedule. You will learn about the information requirements for SCIP dossiers and be able to complete mandatory and optional fields with confidence. You will gain an overview of the IUCLID functionalities and be able to reliably create and submit your SCIP dossiers to the ECHA.
