

The EU Packaging and Packaging Waste Regulation (PPWR) replaces the previous Packaging Directive. It introduces uniform, directly applicable EU requirements for packaging and packaged products. The objectives are to reduce packaging waste, conserve resources, and enhance the recyclability of packaging throughout its entire life cycle.

The PPWR applies to all economic operators who place packaging or packaged products on the market, including importers. Through its close integration with the Ecodesign Regulation (ESPR), the Waste Framework Directive, and the Digital Product Passport (DPP), the PPWR becomes a central building block of the European circular economy.

>> OBJECTIVE

You will understand the structure, objectives, and key requirements of the PPWR and be able to confidently evaluate its impact on products, packaging, and business processes. You will learn practical ways to implement new material, design, reuse, and labeling requirements and integrate them into existing processes at an early stage.

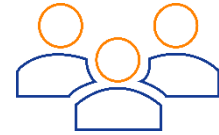
